The CEO will play a key role in advancing the **professional recognition of Creative Arts Therapies** nationally and internationally, while ensuring effective governance, strong advocacy, and high-quality member services. This leadership position will oversee day-to-day management, legal and financial compliance, and the implementation of IACAT's strategic goals.
